

## Middle School: Grades 5-8

### OVERVIEW

#### Deposit

All payment plans require a non-refundable \$2,000 tuition deposit per student due upon enrollment to reserve a space in the class. The deposit is applied toward tuition.

#### Payment Plan Terms

*Semi-Annual and Monthly Payment Plan options are available for an additional fee.*

##### **Annual Plan Tuition:**

One payment due April 2026.

##### **Semi-Annual Plan Tuition:**

Two payments; 60% of tuition due April 2026, remaining balance due October 2026.

##### **Monthly Plan Tuition:**

Ten payments due April 2026-January 2027.

#### Billing & Payment Through FACTS

Families are required to set up and maintain a FACTS Tuition Management account for payment of tuition and fees.

Shorecrest accepts payments made by EFT (Electronic Funds Transfer) from a checking or savings account or by credit card (subject to a 3.05% convenience fee) directly to FACTS Tuition Management. Shorecrest also accepts payments made via personal check, cashier's check, bank check or money order.

Tuition includes lunch and Shorecrest Community Association membership. Tuition payments do not cover the cost of uniforms, books, supplies, transportation, special event admission fees or other expenses incurred in the ordinary course of a student's activities at Shorecrest. All other charges will be itemized when billed. All charges, including tuition, must be kept current. A late fee will be assessed if payments are not made as scheduled in FACTS.

#### Tuition Refund Insurance

Families are automatically enrolled in the Tuition Refund Insurance plan unless they choose to opt-out during the re-enrollment process, if eligible.

Families may not opt out of the Tuition Refund Insurance (2.6% of tuition cost) if the Semi-Annual Plan or Monthly Tuition Plan is selected AND one of the following is true:

- a new family enrolling a student in Shorecrest for the first time
- a new student enrolling after the school year has begun
- a student returning to the School after an absence of one semester or more.

Enrollment contracts obligate families to pay the full year's tuition unless the School is notified in writing prior to June 1, 2026 that your student will not be attending Shorecrest during the 2026-2027 school year. Insurance is especially beneficial for those who may be relocating or may need to withdraw a student for any reason during the school year.
